This permit report is for Rattling Cave in Cocke County, Tennessee. The permit was issued to Chris Ogle of Tennessee Wildlife Resources Agency (TWRA). Myself and TWRA would like to thank SCCi for your support and partnership in conducting this survey. We look forward to continued efforts with SCCi in the conservation and monitoring of Rattling Cave.

On February 1st, 2019 Chris Ogle (TWRA), Daniel Istvanko (TWRA), Reilly Jackson (UTK), and Mallory Tate (UTK) conducted a gray bat census of Rattling Cave. Upon rappelling into the cave, we first surveyed the short passages to the west where we found fewer bats utilizing this section than in 2017. We then headed to some passages to the South, where we encountered several more bats than in 2017. We then continued to head toward what was called "The Basement" on the map. Here is where we encountered most of the bats. After using a density estimate method, we quickly moved out of the basement. While Daniel and I were in the basement, Mallory and Reilly spent their time in the cave reading bat bands (Please see the table below). We then promptly exited the cave due to the arousal nature of gray bats.

Conclusions:

Rattling Cave is a priority gray bat cave for TWRA. It is TWRA's hope that we can continue to monitor this cave possibly with a census every 2 years, which is the timeframe for our other gray bat caves in the state. We would also like to continue monitoring this cave over the summer with thermal imaging and harp trapping.
